Healthy Youth Survey 2018 - Changes from the 2016 Survey

February 9, 2018

Background

Survey Forms A, B, and C

To manage the length of the survey with the breadth of information desired by stakeholders, there are two questionnaires for grades 8, 10, and 12: Forms A and B. The 6th grade questionnaire is a single version (Form C), with fewer questions.

"Core items" are those that are on Forms A and B. Most of the core items are also on Form C.

Form A

The 2018 Form A has 135 questions. This is 5 questions shorter than the 2016 questionnaire.

Form B

The 2018 Form B has 122 questions which is the same as the 2016 questionnaire.

Form C

The 2018 Form C has 91 questions which is 3 questions shorter than the 2016 questionnaire.

Schools may choose to not administer questions on sexual behavior, orientation, and gender identity in which case they will need to tear off the page from survey forms A and B in 2018.

Revision Process for 2018 Healthy Youth Survey

In 2016, the Healthy Youth Survey Planning Committee (HYSPC) took a new, more comprehensive approach to the questionnaire revision process. During previous survey cycles, Form A and Form B revisions followed two different processes. This year, in preparation for the 2018 survey, the HYSPC followed one process for the entire Healthy Youth Survey (HYS). The aim was to increase collaboration and facilitate broader stakeholder involvement in revisions, while also streamlining the process to reduce burden on stakeholders interested in multiple topical areas on the survey. HYS stakeholders had several opportunities and mechanisms to provide input on the survey questionnaire and review and provide feedback on new question proposals as well as changes proposed to existing questions.

Criteria for Questions

The HYSPC began with developing criteria to evaluate questions. The criteria provided a framework for all HYSPC decisions that followed. The criteria were shared with stakeholders during the revision process and are included at the end of this document.

Stakeholder Feedback Process & Question Pre-Testing

Following the 2016 HYS release, the HYSPC sought feedback from stakeholders during the month of May. The HYSPC combined this feedback with comments received throughout the prior two years (since the previous revision process) and state member agencies. During this time, new question proposals were solicited from stakeholders.

The proposed questions and survey revisions were discussed with stakeholders during two all-day meetings and one part-day meeting that were held via in-person and webinar during the month of July. At these

meetings, additional feedback was collected. The committee noted all stakeholders' input to include in decisions.

Decisions were communicated with stakeholders in the fall for a "fatal flaws" review of the intended changes. In addition, new questions and some questions with wording were pretested for comprehension in focus groups among youth in some Washington communities. The HYSPC made some final tweaks based on the additional stakeholder feedback and the results of these pilot tests with youth.

Finalized Questionnaire

Taking into consideration all the stakeholder input and state priorities, while accounting for the length of each form and burden on students, which prevents all proposed questions from being added – the 2018 HYS questionnaire is finalized. Changes for the 2018 survey by topic are listed below.

The Planning Committee would like thank to everyone who was involved in this process. We recognize that providing electronic feedback, developing proposals for new questions, and attending all-day meetings requires a large commitment of time and effort. Without your dedication to the questionnaire, the Healthy Youth Survey would not be the valued data source that it is.

Summary of Changes:

Demographics and general information

Questions on migrant status and mobility were added on Forms A and C and a question on school attendance was added on all three forms. Changes were made to response options to both the living situation questions, and the sexual orientation question on Forms A and B. A new gender identity question was added on Forms A and B. The existing dichotomous gender question was revised on all three forms.

Alcohol, Tobacco and Other Drug Use - Lifetime Use

Lifetime use questions on all forms stayed the same, but response options were expanded to be able to tease out the past-year use of any substance. These changes will be made on Forms A and C.

Alcohol, Tobacco and Other Drug Use - 30-Day Use

The drug used for quality checks was revised on all three forms. In addition, 30-day use of smoking tobacco in a pipe was rotated on Form B.

Other Tobacco-Related Questions

Age at first use of vape pens was added on Form B. All substance use on school property questions were combined in one 'select all that apply' question to conserve space on Forms A and B.

Other Marijuana-Related Questions

A new question measuring simultaneous use of marijuana and alcohol in the past 30 days was added on Form A. Response options were revised for the marijuana question that provides information of method of use among youth who used marijuana in the past 30 days.

Other Alcohol and Drug-Related Ouestions

A new question that provides more information on prescription and OTC drug use among youth was added on Form A.

Nutrition and Fitness

Form B rotated off 1 nutrition question in 2018. Questions on screen time were revised to update the examples on Forms B and C. The question on source of chips or similar snack item was rotated on Form B.

Health Conditions and Health Care

The guestion on medical check-up was rotated on Form B.

Sexual Behavior

The term 'sexual intercourse' was revised to 'sex' and a definition of sex was added for the sexual behavior questions on the tear-off of Form B. The existing condom use question was revised to include both pregnancy and sexually transmitted infections prevention, and therefore the response options were expanded to include all types of birth control used.

Disability Module

The disability module was rotated back on Form B.

Unintentional Injury

The helmet use question was rotated back on Form C. The life vest question and riding with a texting or emailing driver were rotated off from Form B. Riding with a texting or emailing driver remains on Form C.

Intentional injury

The question on carrying a gun in the past 30 days was rotated off from Form B.

Physical, Emotional and Sexual Abuse

A new sexual abuse question was added on tear-off on Form B.

Social and Emotional Learning

The social and emotional learning scale questions were dropped from Forms B and C.

Ouality of Life related

Four quality of life questions were rotated off; and four questions from Children's Hope Scale were added on Form B.

Gambling

The gambling question was rotated off from Form A.

Bullying/Harassment related

The definition of bullying was revised and the electronic bullying and sexting questions were updated on Form B.

School support & Prevention

Two school support questions were rotated off from Form B.

Perceived Availability of Handguns

The question on perceived availability of handguns was rotated on Form B.

Laws and Norms

The questions on laws and norms were revised for consistency so that all include phrasing of 'neighborhood and community' on Forms A and C.

Interaction with prosocial peers

Five questions consisting the interaction and prosocial peers scale were rotated off from Form A.

Belief in Moral Order

Form A rotated off four questions related to belief in moral order.

Prosocial Involvement

The three questions on prosocial involvement on Form C were replaced with one question that has been on Form A. The response options also changed along with the question.

Social skills

The example of CD in the social skills question will be updated once we get the results from pretesting three different options.

Work-related

The question related to work for pay was rotated off from Form B.

More details on each change summarized above are listed below.

Demographics and General Information

Changes were made to response options to both the living situation questions, and the sexual orientation question on Forms A and B. The existing dichotomous gender question was revised on all three forms.

- During your last school year, how many times did you change schools for reasons other than moving up a grade? [I did not change schools; Once; Twice; Three or more times]. New: Forms A and C.
- Have you or your family moved in the past 3 years to another school district, city, or county for seasonal work in: agriculture, dairy, or fishing? [Yes; No; I do not know]. New: Forms A and C
- During the past 30 days, on how many days have you been absent from school for any reason? Include any day that you missed at least half of the school day. [0 days, 1 or 2 days, 3 or more days]. New: Forms A, B and C.
- How do you currently identify yourself? (select all that apply) [Male; Female;
 Transgender; Questioning/not sure of my gender identity; Something else fits better; I do not know what this question is asking] New: Forms A and B tear-off.

- What sex/gender were you at birth, even if you are not that gender today? [Male; Female]. Revised question wording: Forms A, B and C. Revised the question.
- Which of the following best describes you? (sexual orientation) [Heterosexual (straight); Gay or lesbian; Bisexual; Questioning/not sure; something else fits better; I do not know what this question is asking]. Forms A and B tear-off. Additional response option included.
- Who did you live with most of the time in the last 30 days? [Parent(s), step-parent(s), or legal guardian; Relatives like a grandparent, an aunt, an older brother, but NOT your parents; Foster care parent(s); Adults who are NOT your parents or relatives; Friends of yours with no adults present; On your own; Other] Forms A and B. Revised response options.
- Where did you live most of the time in the last 30 days? [In my own house or apartment that my family rents or owns; In a house or apartment that a relative rents or owns; In a house or apartment with someone who is not a relative; In a shelter; In a car or RV, park, or campground; In a motel/hotel; On the street; Moved from place to place; Other] Forms A and B. Revised response options.

Alcohol, Tobacco and Other Drug Use - Lifetime Use

Lifetime use questions on forms stayed the same, but response options were expanded to be able to tease out the past-year use of any substance. These changes will be made on Form A. Form C lifetime use questions remain unchanged.

Alcohol, Tobacco and Other Drug Use - 30-Day Use

The drug used for quality checks was revised on all three forms.

Other Marijuana-Related Ouestions

Response options were revised for the marijuana question that provides information of method of use among youth who used marijuana in the past 30 days.

• In the past 30 days, on how many days did you: use alcohol and marijuana at the same time so that the effects overlapped (cross fading)? [0 days, 1-2 days, 3-5 days, 6-9 days, 10 or more days]. New: Form A.

New: Form A.

Nutrition and Fitness

Questions on screen time were revised to update the examples on Forms B and C.

The term 'sexual intercourse' was revised to 'sex' on Form B and a definition of sex (sex includes oral, vaginal and/or anal sex) was added for the sexual behavior questions on the tear-off. The response options for the question on sexual contact were revised. The existing condom use question was revised to include both pregnancy and sexually transmitted infections prevention, and therefore the response options were expanded to include all types of birth control used.
